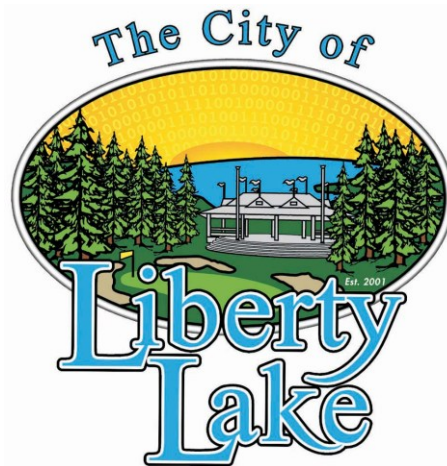

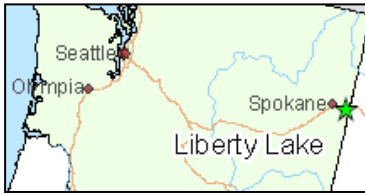

THE COMMUNITY



Located just over a mile west of the Washington-Idaho border in the heart of the Inland Northwest, Liberty Lake is approximately 16 miles east of Spokane and 16 miles west of Coeur d'Alene, Idaho. Liberty Lake is home to over 14,000 residents and is experiencing rapid growth, with the population expected to hit 21,000 by 2035. Liberty Lake is a safe, family-friendly and engaged community that offers great civic pride, quality recreational and educational opportunities, abundant trails and green space, and many golf courses.

The lake of which the City is named after was made through glacial activity and is surrounded by hills on three sides, which offer stunning panoramic views. With all four seasons represented, the region has an abundance of recreational activities including five distinct ski resorts within one and one-half hours' drive, 75 lakes within an hour's drive, many hiking and biking trails and abundant golfing opportunities to enjoy.

Liberty Lake's numerous community volunteers support special events and many family-focused activities each year for residents and visitors to enjoy. From bike rides and a Farmers Market to the 4th of July celebrations and Movies in the Park, there are many activities for enjoyment and relaxation for every age group.



In addition to recreation and relaxation, Liberty Lake is known as a family and business friendly community. The City's business environment supports a diverse, sustainable, and financially secure economic base, and the city is fortunate to be home to many cutting-edge technology companies that include Itron, f5, Open Eye, 2nd Watch, Tier-Point, Altek and other progressive companies.



THE CITY

Incorporated in 2001, Liberty Lake operates with a strong Mayor/Council form of government with seven officials elected at large, serving staggered four-year terms. The City provides Policing, Library, Community Development, Parks and Recreation, and Public Works services. Liberty Lake operates with 105 FTEs and 8 PTEs on a 2026 budget that has approved expenditures totaling \$32,843,745.

The City also owns and operates the Trailhead municipal golf course and helps facilitate countless community events throughout the year, and is well known for being a very active and attractive community with outstanding public amenities. Liberty Lake enjoys strong and positive relations with neighboring jurisdiction and the Greater Spokane Economic Development consortium and transit authority.

THE DEPARTMENT & POSITION

Operating with a 2026 budget of \$1,973,930 and 11 FTEs including the Director, the [Community Development Department](#) is responsible for planning, engineering, and permitting functions that guide growth and development. The department administers land use planning and development regulations, oversees building and development permitting, and provides engineering services for city streets and infrastructure. In addition, the department manages city capital projects and administers activities within the public right-of-way, ensuring that public investments and private development meet adopted standards for safety, functionality, and long-term maintenance.



Reporting to the City Administrator, the Director of Community Development plans, supervises, and coordinates professional engineering and planning work in support of complex projects for the City. The Director provides executive direction for planning, development, and capital engineering initiatives, oversees the work of subordinate and consulting professional and technical staff, and is accountable for the administration and supervision of the Community Development Department.

The Director functions as the City's senior authority for zoning administration; long-range land use, infrastructure, and transportation planning; development code administration, and regulatory oversight. The role provides executive-level advisory support to elected officials and executive leadership, represents the city in public and intergovernmental settings, and ensures regulatory compliance across development activities. The Director is accountable for departmental governance, including budgeting in a priority-based budgeting framework, performance management, staff development, and external funding, and advances economic development, redevelopment, and resilience initiatives supporting long-term community sustainability.



UPCOMING PRIORITIES

The department is completing the city's periodic comprehensive plan update, which must be adopted by December 31, 2026. Following the completion of the comprehensive plan update, the department will be embarking on an across-the-board update of the city's development code. The city is also in the process of reviewing multiple large projects that will reshape the landscape and character of the city's commercial sector. The incoming Director will be responsible for overseeing all these efforts, as well as providing leadership for developing a new economic development strategy.

- A minimum of five (5) years of increasingly responsible professional management experience in planning, economic development, housing, engineering, or real-estate development.



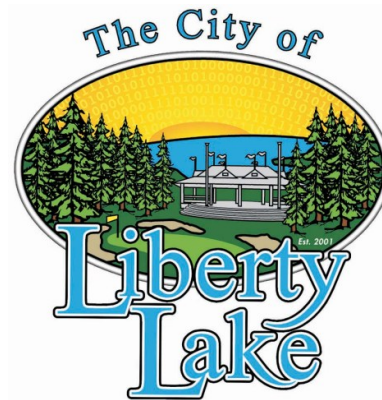
Necessary Knowledge, Skills, and Abilities:
